Pursuant to Regulations 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015, and as per Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, all the members of the Company were given an opportunity to exercise their right to vote on the resolution set out in the Postal Ballot Notice circulated to the members on 26th July 2021.
